The Architectural Committee shall have no liability or obligation to determine whether such improvement, alteration and addition comply with any applicable law, rule, regulation, code or ordinance.

As a condition precedent to granting approval of any request for a change, replacement, alteration or addition to an existing basic structure, the applicant, their hires and assigns thereto, hereby assume sole responsibility for the repair, maintenance or replacement of any such change, alteration or addition. IT IS UNDERSTOOD AND AGREED THAT THE WALDEN LAKE

FAIRWAY VILLAS POA, INC. AND AMERI-TECH PROPERTY MANAGEMENT, INC. ET AL, ARE NOT REQUIRED TO TAKE ANY ACTION TO REPAIR, REPLACE OR MAINTAIN ANY SUCH APPROVED CHANGE, ALTERATION, OR ADDITION, OR ANY STRUCTURE OR ANY OTHER PROPERTY. THE HOMEOWNER AND ITS' ASSIGNS ASSUMES ALL RESPONSIBILITY AND COST FOR ANY ADDITION OR CHANGE AND ITS FUTURE UPKEEP AND MAINTENANCE.

THE HOMEOWNER ALSO AGREES TO PAY FOR ANY EXPENSES RELATED TO MOVING, REMOVING, REPLACING AND/OR ADDING NEW LANDSCAPE SUCH AS BUSHES, TREES, PLANTS, AND GRASS, AND TO THE IRRIGATION SYSTEM PIPES AND SPRINKLER HEADS. THE HOMEOWNERS ASSOC. WILL ARRANGE SUCH AT THE HOMEOWNER'S EXPENSE. A LICENSED AND FULLY INSURED CONTRACTOR IS REQUIRED TO COMPLETE THE WORK REQUESTED. ** A timeline for completion of the project must be included. **

Construction debris must be removed from the project site daily. Any drainage issues that may result from the work will be the sole responsibility of the homeowner to mitigate. If you give permission to the contractor to use the restroom facilities in the pool area, you will need to check it daily, clean up as needed and make sure the door and pool gate is locked.
